UFCW Canada 13th **National Council** Convention

UFCW Canada held its 13th National Convention in Toronto. National Conventions are held every 5 years where delegates from across Canada participate to review the advancements of UFCW Canada and set the course for our union going forward. This is an important convention as resolutions and policy updates are discussed and voted upon. As well, UFCW Canada National Council Elections and Nominations for the Executive Committee are nominated. National Council meetings are always held prior to the International UFCW International Convention.

Delegates from Canada to the International Convention will have an important role in discussing, debating and setting UFCW's goals, priorities and policies, and review and consider amendments to the International Constitution.

More than 350 UFCW Canada delegates, members and special guests participated in the three-day convention hosted at The Westin Harbour Castle Hotel and Conference Centre in Toronto, where the staff is proudly represented by UFCW Local 102.

Through the course of the convention, delegates heard reports on achievements and work of UFCW Canada in several areas: Women and Gender Equity, Human Rights Equity & Diversity, Political Action, Growth Report, Young Workers, Education, Workplace Rights.

Delegates also heard from multiple panelists and guest speakers who introduced several key topics for discussion, including the need for paid sick days, strategies for empowering gig workers and new types of work, climate action planning for related job transitions and new technologies.

Delegates voted in favour of 16 resolutions and policy updates that focused on the above issues as well as reaffirming UFCW Canada's commitment to advancing gender equity and human rights; member inclusion, engagement, and mobilization; safety, health and workers' compensation advocacy; truth and reconciliation and the advancement of social justice.

Delegates also nominated Paul Meinema, Wayne Hanley, Tony Filato, Shawn Haggerty, Kim Novak, and Jeff Traeger for International Vice-President, and elected Filato and Novak as Secretary-Treasurer and Recorder of the UFCW Canada National Council, respectively.

UFCW Canada's 13th National Council Convention concluded with a strategic vision to build strength through unity, inclusion, and shared purpose.

Having a Union Steward is one of the important benefits you gain from belonging to a Union.

Your Union Steward is one of your co-workers who volunteers their time to help employees with any number of issues that come up at work. A Steward helps bring your collective agreement to life and give it meaning by making sure your boss holds up their end of the deal. In doing so, they ensure that Union members receive everything they're entitled to under their agreement.

The most important job of the steward is to build an active, united membership in their workplace. Our ability to defend and improve conditions will always depend on the collective power of our membership.

This September, we resumed in person Shop Steward classes and had a successful Intro to Shop Steward course in the Lower Mainland and Kelowna.

A huge shout out to all the members who attended and participated. If you are interested in learning about our Union and how you can help build Solidarity in your workplace, please contact your Union Representative.

Often the most important role a Union Steward has is to work with the Union Representative to understand and connect to build a better contract and workplace. Your Steward is someone who will speak to your boss on your behalf: They are your mediator. If something happens at work or you notice a problem, your Union Steward is there to help.

Our Union is committed to building these relationships and we will continue to work hard to build the support that all Union members deserve.

As technology evolves, workplace connectivity has also changed. Social media also plays an everincreasing role in connecting with your fellow Union members and with connecting with your Union. It is vitally important that we provide ourselves with the space to give each other full agency and equal respect. No matter what viewpoint you may have. proper discourse includes at least two people allowing engagement in an environment of mutual respect and advancing ideas to make positive change possible.

One of the best ways to create an environment of mutual respect is to demonstrate respectful behavior daily. Each time you interact with your fellow members, be cordial and most importantly be kind. Respect different opinions and avoid using derogatory or divisive language.



Women's Committee Shoe Memorial

Women's rights are an important issue for our union! We are proud of having an active Women's Committee whose goal is to help make a positive difference in people's lives, often at a time when they need it most.

Current members of the Women's Committee include Cathy Maw, Sandra Peters, Dawn Stevenson, Cathy Shannon, Marg Robbins, Alicia Whitehead, Misty Trainer and Tima Dickerson.

December 6th is Canada's National Day of Remembrance and Action on Violence Against Women, and UFCW Local 247 has collected shoes for the Shoe Memorial Event.

It has been 33 years since fourteen women were selectively killed at the Montreal Polytechnique. Government and media no longer widely acknowledge this day. With your support, we will remember the 1000+ women killed in BC by violence since then and before.

The visual impact of so many shoes, with each representing a Mother, a Daughter, a Sister, or a friend who has lost her life from violence, and no longer walks amongst us, has made a difference in the attitudes and reactions of the public since the first Shoe Memorial.

Sadly, women and girls are still dying needlessly!

So again, we have collected shoes and will build our Memorial at the Vancouver Art Gallery on December 6th. Our goal is "that the names of the victims should never be forgotten." They are represented by a pair of shoes and their names displayed.

Join us and pay your respects to those who have been killed.

National Day For Truth And Reconciliation

This day, we come together to acknowledge the tragic history and long-lasting effects of residential schools. This is a day of remembrance, reflection, action and learning. We invite you to wear an orange shirt as a respectful way to honour the lost Indigenous children and survivors, their families and communities.

Gitxsan/Cree artist from Northern BC, Michelle **Stoney**, has given us permission to use her feather design. To her, the feather represents cleansing, as it is traditionally used in smudging. The face at the bottom is not an animal, this is how she draws people and you can see the addition of long flowing hair, which children were forced to cut while attending residential schools.

The importance of education, reflection and being uncomfortable.

Sept 30 is not your conventional federal statutory holiday. The National Day for Truth and Reconciliation is a day to engage with Canada and reflect upon the impact, legacy and intergenerational effects of Residential Schools.

Please take the time to wear an Orange Shirt, have a moment of reflection and let us all move forward together towards reconciliation.

This National Day for Truth and Reconciliation and every day after, let's all show solidarity with Indigenous peoples.

Pride Vancouver 2022 - Local 247

Vancouver Pride Society, 2SLGBTQAI+ communities, queer serving organizations, and allies marched for the first in-person Vancouver Pride Parade in two years.

This year, the BC Federation of Labour organized a Mult-Union Pride Delegation to represent Labour at the Vancouver Pride Parade. 20 Affiliates signed up to march and each affiliate were given 5 marchers total to represent each Union, as this event was scaled down to 50% capacity for Covid Safety.

Safeway members Alicia Whitehead and Fen Williams, Superstore member Dawn Stevenson and Union Reps Steve McAusland and Eric Seto participated in this year's Pride. Union Representative Steve McAusland has a lot of experience volunteering in the community and participating in local community and labour events in his hometown of Victoria. 2023 UFCW International Convention

The UFCW International Convention, held every five years, will take place in Las Vegas, Nevada from Monday, April 24 to Friday, April 28, 2023.

Delegates at this Convention have a number of important responsibilities, including electing International Officers and voting on amendments to the UFCW International Constitution, which will govern our union, for the next five years. Delegates will also debate and set the UFCW's goals, priorities and policies, and review and consider amendments to the International Constitution.

The number of delegates apportioned to UFCW Local 247 is 21. The Executive Board of Local 247 has passed a motion to reduce the number of Delegates to the International Convention from 21 to 14 and the number of alternates to 7. This will result in a significant cost saving to the Local Union. Members of Local 247 must vote to reduce the number of delegates; and only the reduction of delegates requires a vote. Ballots must be returned to us by 12 noon on December 8th.

To stand for nomination and election as a delegate or alternate to the Convention, UFCW Local 247 members must, at the time of the nomination, be an active member of the Local Union who has been an active member in the Local continuously since September 2021. One must also maintain continuous active membership in the Local until the first day of Convention (April 24, 2023). A member may run either as a delegate or alternate, but not for both.

Elected Delegates and alternates will require a valid passport for travel to the United States. They will receive hotel and travel accommodations as well as per diem. The Local will not pay for lost time from the workplace. Elected Delegates and Alternates will be responsible for securing their own time off from work, which may be requested from the employer as per their collective agreement. The UFCW International strongly encourages all participants attending inperson to be fully vaccinated.

Nominations are to be delivered (mailed or emailed) to the Union Office using the nomination form on page 6 of this

Newsletter. Eligibility of those nominated will be verified by the Elections Committee.

Should elections be necessary, a mail referendum will take place and a notice will be mailed as per the International Constitution.

Subject of the result of the reduction vote, members will be electing a maximum of 12 delegates, and 7 alternates, but regardless, you may not vote for more than the maximum number of delegates and alternates allowed. As per the International Constitution, our President and Secretary-Treasurer are automatic delegates to this Convention.

Here is how to vote on the Reduction of Delegates:

- 1) Cut out the "Reduction of Delegates" ballot from the bottom of this page in this newsletter.
- 2) Vote (clearly mark your ballot with an **X** or any other mark, beside your choice).
- 3) Fold & insert ballot into the smaller unmarked pink envelope.
- 4) Seal the pink envelope.
- 5) Insert the pink envelope inside the white envelope addressed to United Food & Commercial Workers 247.

- 6) Seal the white envelope.
- 7) Mark your name and address on the top left corner of the white envelope. Very important!! If not done, your ballot will be spoiled.
- 8) Drop envelope in mailbox. Envelope must be received no later than December 8th, 2022 at 12 pm (Noon).

The result of the vote to reduce the number of delegates will be tallied on December 8th at 2:30 pm.

Here is the Nomination process:

- 1) Complete the Official nomination form found on page 6 of this Newsletter
- 2) mail or email the form
- 3) Deadline to receive the official form is December 8th at 12 pm (Noon).

The LLSC's mission is to cure leukemia, lymphoma, Hodgkin's disease, and myeloma, and improve the quality of life of Canadians impacted by blood cancers.

Since 1985, our UFCW Canada family of members and Local Unions made a pledge to work together to support the efforts of the Leukemia & Lymphoma Society of Canada (LLSC).

Sobeys' Bargaining - Safeway proposals are in!

Collective bargaining is a process used by employers and unions to reach an agreement regarding terms and conditions of employment.

Our job is to present your priorities to your employer and try to get the strongest and fairest deal possible for our members.

All union members employed at Safeway, in the meat, deli, and seafood departments, have had the opportunity to contribute to the creation of bargaining proposals through a survey.

A strong collective agreement requires a collective effort!

At time of printing, the collective bargaining process has begun with written notice to bargain given to Sobeys/Safeway, 'the employer'.

A written notification given by either the employer or the union requires the other party to commence collective bargaining for the purpose of renewing or revising a collective agreement. As soon as notice to bargain is given, it is the responsibility of the employer and union to negotiate in good faith.

Please ensure that your email and phone contact information is updated with your Union to ensure you receive future bargaining updates.
